Committed to Dental Excellence

My object in writing this letter is to inform you that the Union Government, vide Section 3 (f) of the Dentists Act 1948, nominates six members to the Dental Council of India, a statutory body set up under an Act of Parliament to regulate dental education, dental profession and dental ethics in India. DCI regulates and monitors on behalf of the Union Ministry of Health and Family Welfare, deployment

of dental healthcare personnel and helps frame oral health programmes as a part of national health policy. Various State Governments, Universities, Dental Colleges, Medical Council, etc., are represented in the Council. The Indian Dental Association, the recognized body of dental professionals, is conspicuous by its absence. Being the national body of dentists, as a convention, IDA should be given representation in DCI where it could play a significant role in oral health planning and dental education. Currently, IDA does not have any role in the Dental Council of India.

On behalf of the Indian Dental Association, I request the Hon'ble Prime Minister to consider the matter of giving representation to IDA in the Dental Council of India. I would greatly appreciate a favourable decision in this regard.
